Plumbing, Pipefitting and Welding Apprenticeship Openings for Solano & Napa Counties

Applicants must apply in person and may not apply without the required documents listed below.

Face Mask is required when applying and upon entry into the facility.

MINIMUM REQUIREMENTS:

1. Applicant must be at least 18 years of age. Applicants must provide copies of the following documents when applying. **Please note, the copies you provide will not be returned.**
 - A valid Driver License or Valid State issued identification card
 - Birth Certificate
 - Social Security Card
 - Proof of High School Diploma or Legal equivalent is also required: High School Diploma, or G.E.D. or Official sealed Transcripts
 - DD 214 Military Discharge (if applicable)
2. Applicant must be physically able to perform the work of the trade.

TESTING:

Upon completion of your application form, providing all the above documentation is present and applicable, you will be scheduled and notified to take a two-part written exam: Math and Mechanical Aptitude. Applicants who pass the written exam with a minimum total score of 70 percent will be scheduled for an oral interview.

INTERVIEW:

Applicants passing the written exam will be scheduled for an interview with the Joint Apprenticeship Training Committee.
